MECHANICAL MELTDOWN – 4 PLAYER

1. TRAINED OPERATOR **MUST** BE PRESENT AT ALL TIMES. IF OPERATOR IS NOT PRESENT, THE RIDE IS CLOSED.
2. THE OPERATOR MUST ENFORCE ALL RULES AND REMOVE ANY RIDER WHO DOES NOT FOLLOW THE RULES. DO NOT ENTER THE INFLATABLE UNTIL INSTRUCTED TO DO SO BY THE OPERATOR.
3. OPERATOR AND RIDERS MUST NOT BE UNDER THE INFLUENCE OF ANY MIND-ALTERING SUBSTANCE (DRUGS, ALCOHOL, MEDICATIONS, ETC.) DURING OPERATION.
4. RIDERS **MUST NOT** BE PREGNANT, HAVE EPILEPSY, MUSCULAR COMPLAINTS, NECK OR SPINAL (BACK) PROBLEMS, OR ANY OTHER PHYSICAL AILMENT THAT WOULD INHIBIT THE RIDER TO RIDE SAFELY.
5. RIDERS MUST BE AT LEAST 48" TALL AND UNDER 250 POUNDS.
6. RIDERS CANNOT HANG ONTO THE SPINNING ARM OR RIDE THE SPINNING ARM AT ANY TIME. RIDER WILL BE REMOVED IMMEDIATELY IF SO.
7. ABSOLUTELY NO ROUGH PLAY, TUMBLING, FLIPPING OR DIVING ALLOWED.
8. REMOVE SHOES, EYEGLASSES AND ALL SHARP OBJECTS, INCLUDING JEWELRY.
9. NO FOOD, DRINK, OR GUM AND **ABSOLUTELY** NO SILLY STRING. (CLEANING CHARGES WILL BE ADDED)
10. NO WET FACE PAINT.
11. DO NOT OPERATE UNIT IN RAIN, LIGHTNING, DARKNESS, OR IN WINDS EXCEEDING 20 MPH. UNIT MUST BE SET UP UNDER COVER.
12. IF THE UNIT BEGINS TO LOSE AIR, UNLOAD RIDERS. CHECK YOUR POWER SOURCE FOR A POSSIBLE POWER PROBLEM.
13. THERE ARE INHERENT RISKS IN THE PARTICIPATION IN OR ON ANY AMUSEMENT RIDE, DEVICE OR ATTRACTION. PATRONS ACCEPT THE RISKS INHERENT IN SUCH ACTIVITY. PATRONS HAVE A DUTY TO EXERCISE GOOD JUDGEMENT AND ACT IN A RESPONSIBLE MANNER WHILE USING THE EQUIPMENT AND TO OBEY ALL ORAL AND WRITTEN WARNINGS.
14. **THE OPERATOR'S DECISION IS ALWAYS FINAL.**
